- 06/05/15. To agree the minutes of the meeting held on the 8th April 2015 as a true record of the meeting. The minutes were agreed as a true record of the meeting and they were duly signed by the Chairman.
- **07/05/15. Matters arising from the minutes, not covered on the agenda.** There were no matters arising.
- **08/05/15. Co-option of Councillors.** Four councillors have been elected onto the Council. This leaves 4 vacancies which will be filled by co-option. These vacancies will be advertised on the notice boards and the website. The Clerk will prepare a notice asking anyone interested to email or write to her by 1st June.

09/05/15. Planning

a) To make a recommendation on any other planning applications received by the council.

59215 Proposed demolition and extension works to existing single storey wing of dwelling house at The Clock House, East Anstey.

Applicants: Mr & Mrs Copinger-Symes. Comment: East Anstey Parish Council support the approval of this application.

- b) To note the comment made on application 59102. Prior approval of proposed change of use of agricultural building to two dwelling houses (Class Mba). Hillands Farm, West Anstey. Applicant: Mr P Osman. To meet the deadline for responding to this application a response was decided by Councillors and submitted by the Clerk. Comment: East Anstey Parish Council object to approval being granted as they consider the building is not suitable. It was decided that an additional comment should be made about the poor visibility of the access.

- a) District CIIr. CIIr Vigus congratulated CIIr Ley on his re-election. CIIr Ley said there had been no business since the election for him to report on. He is aware the owners of Blackerton have a function room which they are interested in letting out. He commented that he wasn't sure what would happen about the Methodist Hall in the future but the parish would need to be consulted if a decision was made to sell it.

12/05/15. Finance:

- a) To approve invoices for payment. It was agreed to make the following payment: Mrs J Larcombe £85.92 Clerk's salary and expenses (chq no 216). The Clerk noted that the invoice from Allways End Methodist Church for the hire of the hall for meetings, paid at the last meeting, included hire of the hall for the May 2014 meeting which had already been paid for. Mr S Blake, Allways End Methodist Church, has been informed.
- **b)** To agree the Churchyard Grant for 2015/16. It was agreed to give the PCC a grant of £450 towards the upkeep of the Churchyard (chq no 214)
- c) To agree the annual accounts for 2014 2015 and the Annual Governance Statement. The annual accounts for 2014 2015 and the Annual Governance Statement were agreed. The form, which is signed by the Clerk and the Chairman, has to be sent to Grant Thornton for external audit.

Mrs Brock reported that she had contacted Playways about the comment made in the Rospa report about horizontal guardrails without vertical or solid infill for the multi-play piece of equipment. They will put some vertical bars in the gap. Parts have been purchased to repair damage to the flagpole. Cllr Gillett has paid for these and he was asked to bring the invoice to the next meeting so that he could be reimbursed.
